This committee considers all proposed amendments to the National Bylaws and Manual of Procedure, as well as resolutions having any bearing upon the National Bylaws and Manual of Procedure. It makes recommendations to the Convention for approval or disapproval of proposed amendments that may be adopted only in accordance with sections 1401, Bylaws and Manual of Procedure. It also considers resolutions or other proposals pertaining to changes in the VFW Ritual and makes recommendations thereon.

PROPOSED AMENDMENTS TO NATIONAL BYLAWS

C-1 Motion out of order as it requires congressional charter change

Proposed by Department of Georgia

CONGRESSIONAL CHARTER

Sec. 230101 - Organization.

Amend Sec. 230101 - Organization., Congressional Charter, under **(a) Federal Charter.**, by replacing “and airmen” with “airmen and guardians”.

B-1 Motion out of order: Conflict with Charter

Proposed by Department of Georgia

ARTICLE I – MEMBERS

Sec. 101 - Eligibility.

Amend Sec. 101 - Eligibility., National Bylaws, by replacing (2) with the text below and renumbering the current language in (2) and (3) as (3) and (4):

“(2) in a foreign war, insurrection or expedition which service has been recognized with an individual military medal or devices for valor or performance in foreign combat and is governed by the authorization of the award of an individual military medal by the Government of the United States, or”

B-2 Withdrawn and proposed as CiC resolution: defeated 29 July 2024.

Sec. 101 – Eligibility.

“(4) in Cold War Service deployed on the continent of Africa, Asia, or Europe or their territorial waters for not less than 60 consecutive days, between September 2, 1945, and December 26, 1991.”

91 – 99	\$125
100 & over	\$80”

B-9 Rejected: Delegates duties are not outlined and this motion may limit the individual voice of delegate.

Sec. 220 – Vacancies and Removal of Elected Officers or Committee Members.

Amend Sec. 220 - Vacancies and Removal of Elected Officers or Committee Members., National Bylaws, by changing the section title and section language to include “Delegates” and read as follows:

“Sec. 220 – Vacancies and Removal of Elected Officers, Delegates or Committee Members.

Vacancies. All vacancies occurring in the elected offices or delegates of the Post shall be filled in accordance with Section 220 of the Manual of Procedure at the next regular or special meeting as prescribed in Section 203 of the Manual of Procedure.

Removal. Elected officers, elected delegates, or elected committee members may be removed for just cause by the Post or the Department Commander as prescribed in Section 220 of the Manual of Procedure.

Any elected Post officer, delegate, or committee member removed, by reason of failure to pay current dues or under the provisions of this section shall not be eligible to serve in any Post office or committee or as a delegate in the same administrative year in which the officer, delegate, or committee member is removed.”

B-10 Rejected: Motion did not change what is afforded by current bylaws.

Amend Sec. 416 - Elected and Appointed Officers; Chairmen and Committees., National Bylaws, (c), at the end of the sentence, by replacing “required” with “allowed”.

B-11 Rejected: Motion did not change what is afforded by current bylaws.

Sec. 416 – Elected and Appointed Officers; Chairmen and Committees.

Amend Sec. 416 – Elected and Appointed Officers; Chairmen and Committees., National Bylaws, under (c), by replacing the current language with the following:

“The District shall elect or the District Commander shall appoint a Judge Advocate, Surgeon, Chief of Staff or Officer of the Day if appointment rather than election is required by District Bylaws.”

B-12 Rejected: Does not change what is afforded by current bylaws.

Sec. 516 – Elected and Appointed Officers; Chairmen and Committees.

Amend Sec. 516 - Elected and Appointed Officers; Chairmen and Committees., National Bylaws, (c), at the end of the sentence, by replacing “required” with “allowed”.

B-13 Rejected. Position will remain an appointed position.

Sec. 616 – Elected and Appointed Officers; Chairmen and Committees.

Amend Sec. 616 - Elected and Appointed Officers; Chairmen and Committees., National Bylaws, under (a), by adding “Adjutant General” after “Junior Vice Commander-in-Chief”.

Under (b), remove “Adjutant General”.

B-14 Rejected.

Sec. 617 – Nomination, Election, Installation and Term of Office.

Amend Sec. 617 - Nomination, Election, Installation and Term of Office., National Bylaws, by replacing the last paragraph with the following:

“The Commander-in-Chief, Senior Vice Commander-in-Chief, Junior Vice Commander-in-Chief, Chaplain, Judge Advocate General and Surgeon General shall be elected for a term of one (1) year. The Adjutant General and Quartermaster General shall be elected to serve a term of four (4) years with the opportunity to hold a second four (4) term, if elected. National Officers shall assume their duties at the close of the National Convention.”

B-15 Rejected by Roll Call Vote on 29 July during General Business Section.

Sec. 618 – Officers: Duties and Obligations.

“(6) Immediately upon entering office, appoint the Adjutant General who shall be a full-time salaried officer of the organization, subject to approval by a majority of the National Council of Administration.”

B-16 Adopted.

ARTICLE VI – NATIONAL

Sec. 619 – National Committees.

Amend Sec. 619 - National Committees., National Bylaws, in the first paragraph, by adding “c. National Legislative Committee.”

Add the following at the end of the section:

“(c) National Legislative Committee.

(1) Composition: The National Legislative Committee shall consist of committee members appointed by each Department Commander with the approval of the Commander-in-Chief. Department Commanders shall receive one committee appointment for every eight members of the federal Congressional delegation for the states and/or territories that comprise the Department. Appointments to the committee must be approved by the current Department Commander, the current Department Senior Vice Commander, and the current Department Junior Vice

Commander. Committee members shall be appointed to a three-year term with one-third of the committee receiving appointments each year. The Commander-in-Chief shall select a chairman for the committee and shall consult the Senior Vice Commander-in-Chief, Junior Vice Commander-in-Chief, and immediate Past Commander-in-Chief on selection of vice chairs. The Commander-in-Chief may remove committee members for failure to discharge their duties or for other conduct prejudicial to good order and discipline.

(2) Duties: The National Legislative Committee shall formally meet twice each year in Washington, D.C. to conduct training and advance the VFW legislative priority goals in accordance with the organization's legislative and welfare programs and policies approved by the National Convention. Committee members shall continually advance the VFW legislative priority goals in their home states and territories between formal meetings and shall complete monthly activity reports for submission to the Adjutant General or the Adjutant General's duly appointed authority in the VFW Washington office. The Commander-in-Chief may call additional meetings of the committee or promulgate General Orders necessary to the committee for the effective discharge of its business. Committee members shall discharge all duties in compliance with Section 702 of the National Bylaws."

B-18 Rejected: Use of insignia is already accounted for by sections directing QM General.

ARTICLE VII – MISCELLANEOUS PROVISIONS

Sec. 717

Amend Sec. 717, National Bylaws, by adding a section title and the language below:

"Sec. 717 – Prohibition on Personal Gain; Conflicts of Interest.

1. No officer, past or present of the Veterans of Foreign Wars of the United States shall use any VFW title or position he or she currently possesses or has possessed for personal private gain or for the private gain of any family member, personal friend, business associate or other person with whom a personal relationship exists.
2. No officer or member of the Veterans of Foreign Wars of the United States shall at any meeting or any other situation wherein VFW business is being transacted, either formally or informally, participate in any discussion or vote relating to any matter in which he or she may receive personal private gain or any matter that may bestow

private gain on any family member, personal friend, business associate or other person with whom a personal relationship exists. When such a situation presents itself, the officer or member must announce his or her conflict of interest and recuse him or herself from the discussion and/or vote.

3. Nothing within this Section shall be interpreted to preclude an officer, past or present or a member of the VFW from referencing their VFW membership or any VFW position held when describing his or her professional experience or involvement in a veteran service organization so long as the officer, past or present or member does not infer or imply the VFW endorses any product, service or enterprise. In addition, nothing in this Section shall be interpreted to preclude an officer, past or present or a member of the VFW from engaging in organizational sponsorship activities under the same terms and conditions offered to the general public.”

Amend Sec. 902 - Offenses., National Bylaws, No. 5., by adding the following at the end of the sentence:

“as long as the conviction, the guilty plea, or no contest plea, occurs after being accepted as a member.”

B-20 Rejected: 1 year is too short of a time span.

ARTICLE IX – DISCIPLINE

Sec. 903 - Procedure for Disciplinary Actions.

Amend Sec. 903 - Procedure for Disciplinary Actions., National Bylaws, under (a), by adding the following as (4):

- “4. No Disciplinary Action may be taken with respect to the act or acts of a member unless the Disciplinary Action has been initiated in accordance with Section 903(c) of the National Bylaws within one year of the offense having been committed but said time period shall be extended where the member has taken steps to conceal the act or acts from discovery in which case the one year period of time begins upon the date of discovery.”

ARTICLE IX – DISCIPLINE

Sec. 907 - Penalties.

Amend Sec. 907 - Penalties., Manual of Procedure, by removing “(See Section 907 of the Bylaws)” next to the section title and add the following:

“The penalty imposed upon a member shall be commensurate with the offense or offenses committed and should be corrective in nature reserving the most serious penalty of membership termination for the most egregious offenses. In determining an appropriate penalty under Section 907 of the National Bylaws, the adjudicating officer, adjudicating panel, appellate official or appellate body shall consider the following factors:

1. The nature and seriousness of the offense and its relation to: (a) membership within the Veterans of Foreign Wars; (b) the member’s duties and responsibilities in an elected or appointed position in the Veterans of Foreign Wars; (c) whether the offense was intentional or technical or inadvertent; and (d) whether the offense was committed maliciously or for gain or was frequently repeated;
2. The member’s past disciplinary record within the Veterans of Foreign Wars;

3. The member's past contributions to the Veterans of Foreign Wars and its mission including length of membership, volunteer activities and performance in appointed or elected positions;
4. Consistency of the penalty with those imposed upon other members for the same or similar offenses;
5. The impact of the offense upon the reputation of the Veterans of Foreign Wars and its members outside the organization;
6. The clarity with which the member was on notice of any rules that were violated in committing the offense or had been warned about the conduct in question;
7. Potential for the member's rehabilitation;
8. Mitigating circumstances surrounding the offense such as unusual personal issues, personality problems, mental impairment, harassment or bad faith, malice or provocation on the part of others involved in the matter; and
9. The adequacy and effectiveness of alternative sanctions to deter such conduct in the future by the member or others.

When applying these factors to determine an appropriate penalty under Section 907 of the National Bylaws, the adjudicating officer, adjudicating panel, appellate official or appellate body shall balance the needs of the Veterans of Foreign Wars to maintain good order and discipline with the membership rights bestowed upon a member by the National Bylaws. Where a lesser penalty set forth in Section 907 of the National Bylaws achieves the proper balance, the adjudicating officer, panel or appellate official or body shall choose the lesser penalty."

Amend Chapter Title - Funeral Ceremonies, Ritual, by adding the following new subsection after subsection “CHAPEL SERVICE”:

“CHAPEL SERVICE FOR GOLD STAR MEMBERS

We, the members of _____ Post No. _____, Veterans of Foreign Wars of the United States, are here assembled to pay a lasting tribute of respect to our departed comrade *and Gold Star mother/father; husband/wife*. When the call of our country was heard Comrade (deceased) answered; self was forgotten in the cause of the greater good. Bravely they marched away with the abiding faith in their God, their country and their flag.

The red of our country’s flag was made redder by their heroism; the white more stainlessly pure by the motives which impelled them; and, in the starry field of our nation’s glorious banner, the blue has been glorified by the service they have given for American ideals.

(Name of Comrade) further gave to the defense of our great nation the most precious and painful gift of all, that of their son/daughter; husband/wife, (announce name of the deceased child or spouse), who gave his/her life in the service and defense of the United States.

Parade rest. (Detail responds.) The Chaplain will invoke the divine blessing. (Detail hold caps

over heart with right hand.)

Chaplain: (May extemporize or repeat): “O God, Father of us all, we here extend these final earthly tributes to our beloved comrade. Accept our prayers on behalf of the soul of Thy servant departed. (All repeat Amen. Replace caps.)

(A choir, quartet or soloist may sing “Sleep, Soldier Boy” or other appropriate song.)

Commander: One by one, as the years roll on, we are called upon to fulfill these sad duties of respect to our departed comrades.

Attention! Officers of _____ Post _____, Veterans of Foreign Wars of the United States, you will now perform the last duties of your stations.

Junior Vice-Commander: (Faces the casket, approaches it, stands before the blue field of the casket flag in such position that their back is not toward the assembly. They fold back the blue corner of the flag to leave bare a portion of the casket. Then places the evergreen upon the casket and declares so all will hear):

“On behalf of _____ Post _____ Veterans of Foreign Wars of the United States, I present this evergreen tribute as a symbol of our undying love for our comrade.

(Junior Vice-Commander salutes casket and returns to their place in the line.)

Senior Vice-Commander: (Takes same position at the casket. Laying white flowers upon casket and says): “I place these white flowers as a symbol of purity upon this casket, and may each future generation emulate the unselfish devotion to duty even to the last of our comrades.

(Senior Vice-Commander salutes casket and returns to their place in line.)

Officer of the Day: (Takes same position at the casket. Laying wreath upon casket and says):

“We place this wreath as a last token of affection from their comrades-in-arms upon the casket of our departed comrade and crown their mortal dust with this symbol of victory.”

(Officer of the Day salutes casket and returns to their place in line.)

Chaplain: (Placing a gold or yellow flower upon the casket and says): I place this symbol upon you in honor of the glorious sacrifice you made in life; that of your son/daughter; husband/wife in defense of our nation. With all of the admiration and reverence that we possess for your life and for the life of your child/spouse. May this most precious of tokens serve as an emblem of your grace and perseverance.

Commander: (Takes same position at the casket. Placing small Flag of the United States upon casket and says):

“On behalf of our glorious republic, for whose integrity our comrades of the Veterans of Foreign Wars enlisted and served, we place upon their casket this emblem of our country, a country whose arms are always open to shelter the oppressed.”

(Commander then replaces folded corner of the casket flag, laying it over the evergreen, flowers, wreath, and flag symbols. Commander salutes casket and returns to their place in line.)

Chaplain: (Delivers brief address extemporaneously or repeats the following):

We come today to honor the memory of one who offered their life as a service to our nation’s cause and to our God. Proudly we remember their service. Because of men and women like our comrade, we live in a land freedom, peace and justice. May our ceremonies of today deepen our reverence for our honored comrade and friend.

We believe that our comrade is now in the hands of our Heavenly Father, the Supreme Commander and Judge of all. We lay our comrade’s body (ashes) to rest. Let us cherish their virtues and learn to imitate them. Let each of us be loyal and faithful to our remaining missions in life that we too will be able to join in that grand fraternity which is on earth and in heaven, and remains unbroken.

We realize how futile mere words are to express our deep and abiding sympathy in our loss. May we be comforted by the assurance that our comrade, friend and loved one is at rest in God’s eternal peace, and abides in a place where all burdens are lifted and there is no more sickness and pain.

When the call of our country was heard, their son/daughter; husband/wife (announce name of the deceased child or spouse) answered. He/she bravely marched away as their mother/father; husband/wife too so greatly sacrificed in their absence, knowing that they may not return.

There is no purer form of sacrifice or duty than that of those who lost a child/spouse in the service of their country.

One by one, as the years roll on, we are called upon to fulfill these sad duties of respect and reverence. We shall miss (name of departed Gold Star) and their hard attained wisdom, words of counsel, and watchful care over the memory of their son/daughter; husband/wife and in so doing, care over the memory of our nation.

Attention!

Commander: Officers, you will now perform the last duties of your stations.

Senior Vice-Commander: (Places a white flower upon the casket and says): As a symbol of purity, I place this flower upon you in remembrance of your departed life. For as much as it has pleased God to take out of this world the soul of (departed Gold Star) it shows how beautifully true is the comparison of life to this flower, which opens in the morning, but in the evening withers away. May each future generation emulate such unselfish devotion.

Chaplain: (Placing a gold or yellow flower upon the casket and says): I place this symbol upon you in honor of the glorious sacrifice you made in life; that of your son/daughter; husband/wife in defense of our nation. With all of the admiration and reverence that we possess for your life and for the life of your child/spouse, may this most precious of tokens serve as an emblem of your grace and perseverance.

Chaplain: We have come today to honor the memory of one who offered so much to God and to our Nation's cause, that of their child/spouse. Because of fathers/mothers; husbands/wives like (name of departed Gold Star) who were willing to give so greatly and who raised God's

children to love and honor Him and their country, we are therefore able to live in a land of freedom, peace, and justice. Let us cherish their virtues and learn to imitate them.

May our ceremonies today deepen our reverence for our departed friend, who we believe is now in the hands of our Heavenly Father.

We realize how futile mere words are to express our deep and abiding sympathy in your loss. May we be comforted by the assurance that our friend is at rest in God's eternal peace, and abides in a place where all burdens are lifted, where there is no more sickness, and where there is no more pain.

Let us pray: Heavenly Father, who art our refuge and strength in our time of trouble, enable us we pray, to put our trust in Thee. Amen."

BYLAW AMENDMENTS

Section 1401 of the National Bylaws states:

“Any member in good standing, a Post, a District, or a Department, may propose an amendment to the National Bylaws; provided, however, before consideration at the National Convention, the proposed amendment must be approved by a Department Convention. Immediately following a Department Convention, the proposed amendments must be forwarded to National Headquarters.

A national officer may propose an amendment to the National Bylaws and forward the proposed amendment to the Adjutant General.

All proposed amendments will be available to each Post by the Adjutant General at least fifteen (15) days before the assembling of the National Convention.

Amendments require a two-thirds vote of the delegates present and voting at the National Convention.

All amendments adopted at any National Convention according to the provisions of this section shall take effect thirty (30) days after the final adjournment of the National Convention at which they were adopted, unless specifically stated otherwise in the amendment.”

MANUAL OF PROCEDURE AND RITUAL AMENDMENTS

Section 1401 of the Manual of Procedure states:

“The Manual of Procedure and Ritual may be amended by the Council of Administration by a majority vote of the members present and voting at a regular meeting as prescribed in Section 622 of the Bylaws.

The Manual of Procedure and Ritual may be amended by the National Convention by a majority vote of the delegates present and voting provided that such amendments have been forwarded, through channels; have been properly approved; and, have been proposed by a Post, a District, a Department, or recommended by a National officer. All proposed amendments will be available to Posts by the Adjutant General at least fifteen (15) days before the assembling of the National Convention for those amendments being proposed for consideration at the convention.”

The Manual of Procedure contains material in the Bylaws as well as additional explanatory material.

A change in the Bylaws automatically changes the Manual of Procedure and it is not necessary to act individually on the corresponding Manual change.

CONVENTION RULES
125th National Convention
Veterans of Foreign Wars of the United States
Louisville, Kentucky

1. That, in accordance and conjunction with the National Bylaws and Manual of Procedure, and with any exception noted here, the current edition of Robert's Rules of Order Newly Revised shall be recognized as parliamentary authority for this Convention.
2. That when a registered delegate desires to make a motion or address the Convention, the delegate shall rise, address the Chair as "Comrade Commander-in-Chief," and after being recognized, shall state their name, Post number and Department before proceeding.
3. A registered delegate shall be permitted to speak but twice on any one subject, or any pending resolution for a period not to exceed five minutes each except by consent of two-thirds of the voting strength of the Convention present and voting, provided that chairmen of Convention committees may speak as frequently as necessary in connection with reports of their committees. In the event of controversy, the presiding officer shall not entertain any motion which will curtail further debate without affording the maker of the motion or a member of the delegation presenting the resolution an opportunity for five minutes of final rebuttal.
4. All resolutions offered by individual registered delegates must bear the endorsement of the Department Commander or, if absent, the Department Adjutant. All resolutions must be submitted to the office of the Adjutant General for numbering and referral to committee no later than 12:00 p.m. Wednesday, July 31, 2024 and must be accompanied by a written explanation as to why the resolution was not presented to the Department Convention for consideration.
5. All resolutions offered on the floor at the Convention will initially be in writing, and shall automatically and without reading, be referred to the Adjutant General for assignment to the proper committee.
6. Committee chairmen, in reporting on resolutions referred to their committee, shall first read the number of those resolutions on which favorable action is recommended. Specific resolutions may be set aside for individual action at the request of any delegate, the others being voted upon collectively. After action has been taken on all such resolutions, the chairman shall read the number and title of those resolutions which the committee has disapproved. A resolution disapproved by the committee shall be automatically rejected unless a motion is made and seconded that it be approved, in which case it shall be brought up for debate and Convention action.
7. This Convention will not consider any resolution dealing with the expenditure or appropriation of organizational funds.
8. The Convention will not consider any resolution endorsing legislation sponsored by any other veterans' organization, or requesting us to join with any other organization in sponsoring legislation not expressly proposed by the members of the Veterans of Foreign Wars of the United States.

9. Only delegates to this Convention may speak in debate, make motions and vote during Convention proceedings.
10. Delegates shall vote individually on any item of business coming before the Convention and cannot be required to vote as a block with others from their delegation.
11. Voting strength shall be determined by those delegates registered as of the close of the credential registration booth the previous day and as reported to the National Convention. The Department Commanders will receive, prior to the beginning of each business session, a list of posts that have properly registered delegates. Only delegates representing those Posts listed on the report will be accorded voting privileges.
12. If a roll call is required, the following is the order of voting precedence: National Officers, Past Commanders-in-Chief, National Council of Administration, Department Commanders followed by Unaffiliated Posts. Ascending alphabetical order by Department will be utilized for the National Council of Administration and Department Commanders. The Department Commander of each delegation shall poll their delegation's registered delegates on the floor and shall announce the vote of their delegation.
13. Registered delegates of a delegation may arrive at a vote in any manner, but shall announce it in terms of full units and not in terms of a fractional part of a vote.
14. Reconsideration of a motion or resolution upon which final disposition has been made shall not be allowed after the meeting at which it was acted on has been recessed, unless the body is notified of such contemplated action prior to the close of that meeting.
15. When the report of the Department Commander of the delegation is not acceptable to all registered delegates of the delegation and a poll of the Department registered delegates is demanded by three registered delegates of said Department, the Adjutant General shall poll the registered delegates, without discussion of question.
16. In accordance with Section 621 of the National Bylaws, voting shall be by acclamation as defined within Robert's Rules of Order, Newly Revised, except a roll call may be demanded by ten registered delegates representing Posts in ten separate Departments, or by order of the Commander-in-Chief.
17. Nominating speeches for the National officers shall be limited to five minutes each. The time allocated to encompass all seconding speeches shall be limited to four minutes total. Nomination and election of National officers will be held according to the Congressional Charter, Bylaws, and Section 617 of the National Manual of Procedure.
18. Registered delegates and persons recognized by the Chair shall be entitled to a respectful hearing, and the Chair shall have the authority to clear the gallery or the floor or have the Sergeant-at-Arms escort from the floor any person or persons who may create any disturbance which interferes with the orderly procedure of the Convention.
19. The Commander-in-Chief may, as may be necessary and appropriate to informing the membership of the activities of this Convention, authorize that all or parts of the Convention be streamed through the website of the Veterans of Foreign Wars of the United States.
20. Consent of two-thirds of the voting strength of the Convention present and voting is necessary for suspension of the rules of this Convention.
