Greetings Comrades,

Well, another VFW year is coming to an end. It has been a pleasure and an honor to serve this great organization and all the amazing members. My fellow members, Post, District, Department, and National leaders have taught me many things over the year.

State Convention is right around the corner. If you haven't already booked a room, they need to be booked by the 5th to get the Department rate. Banquet tickets are on sale and will be available until June 19th. I will not be able to accept any orders after that because I have to give the hotel the final count by the 20th. If you are mailing an order in and are not certain that I will receive it before the 19th, just call, text or email me and let me know how many you are ordering and which meals. The agenda for State Convention will be included in these GOs.

The relief committee will be holding another fundraiser during the convention. Comrade Duncan will have the details of it to me in the coming days and I will get them out to the members. I can tell you this will be another fun one.

Comrade Danny Medley is asking any Districts that did not bring something to raffle for the National Home to please bring it to State Convention. Please contact him to let him know if you are bringing something or if you have any questions at 918-752-4127.

You will notice SOI/OTS in the Dates to Remember section of these GOs. There will be more details coming in the following weeks.

Pursuant to Section 416: “Additionally, District Commanders, District Senior Vice Commanders, and District Junior Vice Commanders shall submit proof of eligibility to the Department Adjutant.” I would ask that **ALL INCOMING** District Commanders, District Senior Vice Commanders, and District Junior Vice Commanders please send their proof of eligibility to me **PRIOR** to the convening of the State Convention.

COMMANDERS & ADJUTANTS: Pursuant to **MOP, Sec 222**, Delegates and alternates for the District Convention and Meetings, Department and National Conventions shall be elected a regular meeting in April. Delegate strength will be based on members in good standing as of March 31st. Comrades, on 31 March 25, I will go into the Online Membership System (OMS) and obtain the members in good standing for each Post within our department. Shortly after, I will be publishing a delegate strength roster showing the number of delegates for each Post. This will be your delegate strength for all conventions at District, Department, and National Level. Included on the form will be the Department Delegate Dues owed by each Post. A delegate worksheet is also available with these General Orders. Delegate worksheets must be mailed, emailed, or turned into the Department registration table prior to convention voting.

Pursuant to **VFW-Oklahoma Bylaws, Article 5,**

Section 2, *Delegates and alternates for the District Convention and Meetings, Department and National Conventions shall be elected at a regular meeting in April. Delegate strength will be based on members in good standing as of March 31st.*

Section 3, *A delegate registration fee established by the Council of Administration will be paid by each Post for every delegate to which it is entitled and by others authorized to cast a vote as defined by the national Bylaws. This fee may be increased/decreased at each succeeding convention by the Council of Administration. Said fees shall be paid to the State Quartermaster 15 days prior to the opening session of the Department Convention. Anyone wanting to register after this date will be assessed an additional fee of \$1.00 for each delegate registered. Post delegate fees are due and payable regardless of convention attendance. Posts that do not pay prior to the convention will be assessed the delegate fees at the plus \$1.00 rate.*

In the links with these general orders, you will find the DEPARTMENT delegate worksheet. As stated above, your delegates should be elected at the same meeting in which you

elect post officers. This worksheet should be filled out and sent back to me at vfwhqokqm@outlook.com, vwokadj@outlook.com, or mailed to the Department at PO Box 1126, OKC, OK 73101. I am still needing several Delegate worksheets. Please try to have these back to me before the State Convention so that the delegate badges can be prepared in advance.

As a reminder whether your Post attends the State Convention or National Convention or not the delegate dues are required to be paid. National dues are \$25 for the first delegate and an additional \$10 for each added delegate. The Department dues for each post can be found in the “Post Delegate Dues” link. These dues should be received by the Department by June 12th. Any dues not received by this date will incur an additional \$1.00 fee.

1. a rule made by a company or society to control the actions of its members.

"the expulsion comes as a result of violation of the fraternity's constitution, rules, and by-laws"

According to the Merriam-Webster Dictionary, a bylaw is "a rule adopted by an organization chiefly for the government of its members and the regulation of its affairs."

And according to The Law Dictionary:

Bylaw

Definition and Citations:

(Sometimes also spelled by-law or byelaw) can refer to a law of local or limited application, passed under the authority of a higher law specifying what things may be regulated by the bylaw, or it can refer to the internal rules of a company or organization.

The podium edition of our CONGRESSIONAL CHARTER, BYLAWS, MANUAL OF PROCEDURE, AND RITUAL contains our bylaws. Our rules and regulations that control how, where, when, and why we do things. They are not up for debate or considered a suggestion. They are our internal rules. If you have questions about them, don't go off what was done in the past or I think it's this, read the current book. A new one comes out every year. If you have questions about what they say, the Department of Oklahoma has three people who I consider experts on the bylaws, talk to them and ask. Ask Gordon Wheeler, vfw9969@gmail.com, James Dockemeyer, XXXXXXXX, or Randy Traxler, randytraxler@icloud.com. And a reminder, each officer at Post, District, and Department are required to have one in their possession. If you use the PDF version, make sure it is available during meetings.

So why do we have bylaws, simple. If you read and live the purpose of our organization, we need rules so that we can work together to achieve them. Working together to achieve the goal shows a united front. It also allows individual members to know they are working on their part of the goals

So, what is our purpose? Meetings? No, they allow us to develop a plan to meet the goals. Or purpose is:

The purposes of the corporation are fraternal, patriotic, historical, charitable, and educational, and are:

1. to preserve and strengthen comradeship among its members;
2. to assist worthy comrades;
3. to perpetuate the memory and history of our dead, and to assist their surviving spouses and orphans;
4. to maintain true allegiance to the Government of the United States, and fidelity to its Constitution and laws;

5. to foster true patriotism;
6. to maintain and extend the institutions of American freedom; and
7. to preserve and defend the United States from all enemies.

Notice, personal gain is not part of the purpose. Our job, our mission is to support the VFW towards these purposes. When your post thrives, the VFW thrives.

I also want to remind everyone that new members are invited to join but must prove their eligibility to join. Which happens to be in the bylaws. A post must vote the member in and they should honor them with an induction ceremony where the Members Obligation is administered. If you don't, you are denying them their ceremony which lessens their obligation.

MEMBER'S OBLIGATION

In the presence of Almighty God -- and the members of this order here assembled -- I, (name), do of my own free will and accord, solemnly promise and declare that:

I will bear true allegiance - to the Constitution of the United States of America - and I will always be loyal thereto. I do further solemnly promise and declare - that I will comply with the Congressional Charter -- Bylaws and Ritual of this order -- and I will always be loyal thereto -- that I will never wrong or defraud this organization -- nor a member thereof -- nor permit any wrong to be done to either -- if in my power to prevent it. I will never propose for membership - - any person not eligible -- nor one whom I know to be unworthy. I will never make known to anyone -- not authorized to receive it --- any of the work of this order. Should my affiliation -- with the Veterans of Foreign Wars of the United States -- cease in any way -- I will consider this pledge -- as binding outside of the order -- as though I had remained a member of same. All this I promise and pledge -- upon the honor of a true comrade -- and a member of our great republic.

EMAIL PHISHING

Scammers are working harder than ever to steal personal information through phishing emails and text messages (smishing). As part of the **VFW Oklahoma** community, we want to ensure you stay informed and protected.

How to Recognize and Handle Phishing Attempts

◇ **If You Receive a Phishing Email:**

- **Do NOT click on links or open attachments**—they may contain malware.
- **Verify the sender**—look for misspellings or unusual addresses.
- **Report the email:**
 - Use your email provider's "Report phishing" option.
 - Forward it to **reportphishing@apwg.org** (Anti-Phishing Working Group).
 - If it appears to be from a trusted company, report it directly to them.
- **Mark as spam and delete** the email.
- **Enable Two-Factor Authentication (2FA)** on your accounts for added security.

◇ **If You Receive a Phishing Text (Smishing):**

- **Do NOT click links or reply**—this confirms your number is active to scammers.
- **Report the text** by forwarding it to **7726 (SPAM)** and to the **FTC at reportfraud.ftc.gov**.
- **Block the sender** on your phone.
- **Check with the company directly** if the message claims to be from your bank, service provider, or another organization.
- **Keep your phone updated** to protect against security threats.

What to Do If You've Already Been a Victim

If you've clicked on a phishing link or shared sensitive information, take action immediately:

- ☒ **Change your passwords** for any affected accounts.
- ☒ **Contact your bank or credit card company** if you shared financial information.
- ☒ **Report identity theft** to the **FTC at www.identitytheft.gov**.
- ☒ **Scan your devices for malware** if you clicked on a suspicious link.

By staying vigilant, we can protect ourselves and each other from cyber threats. If you suspect a phishing attempt targeting VFW members, please report it immediately.

VFW DEPARTMENT OF OKLAHOMA 2024-2025 BYLAWS COMMITTEE REPORT #1

The VFW Department of Oklahoma Bylaws committee met on 31 January 2025 at 1300hrs at VFW Post 9969 (Del City). All members of the committee consisting of Curt Watts (Post 2027), James Dockemeyer (Post 1317), and Gordon Wheeler (Post 9969) were present for the meeting. All proposed bylaw changes that had been submitted to the Department Adjutant prior to the committee meeting held on above said date were reviewed and discussed in detail on the merits of the proposed change. Once discussion was complete, committee members voted on each proposed bylaw change individually. The committee voted for one of three recommendations; approval, dis-approval, or submitting an amendment to a proposed bylaw change. It is the plans of the committee to meet again after the department deadline for all proposed bylaws changes having been submitted by Posts prior to the department Adjutant prior to the Department convention in June.

Below are the results of the committee's recommendation(s) on each proposed bylaw change submitted to date.

Proposed Department Bylaw Changes submitted by the Department Headquarters

- **SB 1: Article IV Section 3 Paragraph 3**

- **Currently reads:**

- “The elected officers of this Department shall be a Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Chaplain, Judge Advocate, Surgeon, 1 Year Finance Committee Member, 2 Year Finance Committee Member, 3 Year Finance Committee Member, and Immediate Past Commander. “

- **Change proposed:**

- Remove Immediate Past Commander

- **Would read:**

- “The elected officers of this Department shall be a Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Chaplain, Judge Advocate, Surgeon, 1 Year Finance Committee Member, 2 Year Finance Committee Member, and 3 Year Finance Committee Member”

- **Reason for change:**

- Recommendation by the National Inspection team. The Immediate Past Commander is an ex-officio member of the Council of Administration.

*This committee voted to **recommend approval** of the above proposed bylaw change.*

- **SB 2: Article IX Section 2**

- **Currently reads:**

- Conference and Convention Committee:
 - A. A Conference and Convention Committee shall be appointed by the State Commander to conduct the business affairs of the Department Convention, Fall Festival and Mid-Winter Conference.
 - B. The State Adjutant/Quartermaster shall notify all Posts, Districts, State Officers and Past State Commanders within the Department at least fourteen (14) days prior to the convention and other Department meetings of the room rates, registration fees,

banquet rates and all other necessary costs, fees and special conditions or limitation governing rates and conduct during the aforesaid Convention and other Department meetings.

C. The Conference and Convention Committee shall investigate and recommend to the Council of Administration suitable sites for the Department Convention, Fall Festival, and Mid-Winter Conference. The committee shall make their recommendations not later than the Mid-Winter Conference for sites for two years from the following June. The Council of Administration is to have final determination of the convention location.

- **Proposed Change:**
 - Remove paragraphs B and C.
 - Create SOP with further information and details.
- **Would read:**
 - Conference and Convention Committee: A Conference and Convention Committee shall be appointed by the State Commander to conduct the business affairs of the Department Convention, Fall Festival and Mid-Winter Conference.
- **Reason for change**
 - Recommendation by the National Inspection team.

*This Bylaws committee voted to **recommend approval** of the above proposed bylaw change. Furthermore, the committee recommends that the Department Commander immediately appoints and directs the Conference & Convention Committee to write an SOP. Once created, the committee will submit the SOP to the Department Adjutant for review and approval by the Council of Administration; upon approval the Adjutant shall maintain a copy of the approved SOP in Department records.*

- **SB 3: Article IX Section 3**

- **Currently reads:**
 - “The Veterans Service Committee:
 1. Shall consist of the State Commander, Immediate Past State Commander, and three (3) members appointed by the State Commander.
 2. The Committee through the State Commander shall have full control of the service work of the State. It shall appoint and prescribe the duties of all officers and employees of the Department Veterans Service office.
 3. Additionally, they shall be responsible for recommending the hiring, termination, disciplinary or other personnel actions of all other non-elected paid employees under the Department Veterans Service office.
- **Proposed Change:**
 - Remove paragraphs 1, and 3.
 - Create SOP with further information and details.
- **Would read:**
 - “The Veterans Service Committee: The Committee through the State Commander shall have full control of the service work of the State. It shall appoint and prescribe the duties of all officers and employees of the Department Veterans Service office.
- **Reason for change:**
 - Recommendation by the National Inspection team.

*This Bylaws committee voted to **recommend approval** of the above proposed bylaw change. Furthermore, the committee recommends that the Department Commander immediately appoints and directs the Veteran Service Committee to write an SOP. Once created, the committee will submit the SOP to the Department Adjutant for review and approval by the Council of Administration; upon approval the Adjutant shall maintain a copy of the approved SOP in department records.*

- **SB 4: Article IX Section 4**

- **Currently Reads**

- Budget and Finance Committee:

- The Budget and Finance Committee shall consist of the State Commander, State Senior Vice Commander, State Junior Vice Commander, State Quartermaster, and three (3) members. The three (3) members shall be elected at the Department Convention for terms of one (1), two (2), and three (3) years and thereafter one (1) member shall be elected each year for a term of three (3) years.
- The Budget committee shall assist the State Quartermaster to review and submit a proposed annual budget to the Council of Administration for approval at the School of Instruction immediately following the Department Convention. Said budget shall include proposed expenditures for all Department meetings.
- The Budget and Finance committee shall assist the State Quartermaster to review and submit a proposed annual budget to the Council of Administration fifteen (15) days prior to the beginning of the State Convention. The Council of Administration shall consider and take action on the proposed budget at its meeting following the Department Convention. Said budget shall include proposed expenditures for all Department meetings.
- The Department Budget and Finance Committee members shall be responsible to audit the books of the State Quartermaster once each quarter.

- **Proposed change:**

- Replace paragraphs A, B, C, and with “Budget and Finance Committee will assist with budget preparation and be responsible with auditing the books of the State Quartermaster.”
- Create SOP with further information and details.

- **Reason for change:**

- Recommendation by the National Inspection team.

*This Bylaws committee voted to **NOT recommend approval** of the above proposed bylaw change. Due to the nature and importance of the Budget & Finance Committee’s duties and fiduciary responsibilities, this bylaws committee feels that Article IX, Section 4, should stand firm within the current Department bylaws which explicitly states the duties and responsibilities of the Budget & Finance Committee.*

This committee recommends a proposed amendment of its own to Article IX, Section 4.

- **Currently reads** The Department Budget and Finance Committee members shall be responsible to audit the books of the State Quartermaster once each quarter.
- **Proposed change.** Insert “three elected committee” after finance, and before members.
- **Proposed change:** The Department Budget and Finance “**three elected Committee**” members shall be responsible to audit the books of the State Quartermaster once each quarter.
- **Reason for change:** When this bylaw change was adopted approximately three or four years ago, and the State Senior Vice Commander and State Junior Vice Commander were

added to the committee, it was not the intent of the convention delegates to have all committee members audit the books of the Quartermaster, only the three elected committee members along with the Commander. Due to an administrative error, the words “three elected committee ” was not adopted in the wording of the bylaw change that was submitted and approved by the National organization.

- **SB 5: Article IX Section 5:**

- **Currently reads:**

- “Committee on Native American Relations

- A. A Committee on Native American Relations shall be appointed by the State Commander. The Chair is given full authority to appoint members and/or consultants to carry out its prescribed duties. However, at no time shall a member and/or consultant be paid for services rendered without express permission of the Council of Administration.
- B. Committee duties include but are not limited to: Establish relations with each Tribe in the State of Oklahoma.
- C. Establish relations with all Native American veterans’ organizations in the State of Oklahoma.
- D. Relay information between Native American tribes/organizations and the Department.
- E. Encourage Native American combat veteran’s membership in the VFW.
- F. Relay benefit information between Tribes and the Department.”

- **Proposed change:**

Furthermore, once prior arrangements with the hotel/hosting agency have been completed and contracts signed, this could cause legal and/or planning consequences on all parties involved.*

- **SB 11: Article VI, Section 1: Department Meetings, Section 1,**
 - **Currently reads**
 - The department shall have a minimum of three (3) meetings a year. The Fall Festival, Mid-Winter Conference, and Department Convention, with the exception of the Department Convention which shall be three (3) days total, and the other meetings shall be two (2) days in length. The commander -Elect may, at their option, hold their reception at a site, place and date of their choice.
 - **Proposed change** Amend the second sentence to read, The Fall Festival, Mid – Winter Conference, and Department Convention, with the exception of the Department Convention, which will be three or four days (3 or 4) days, total, and the other meetings shall be two or three days (2 or 3) days in length and shall be in the metropolitan Oklahoma City area. The Department Convention and Conferences may be extended one (1) additional day if required due to the amount of business required to be completed during the Convention or Conferences. The Commander -Elect may, at their option, hold their reception at a site place and date of their choice.

- **Would read:** The Fall Festival, Mid – Winter Conference, and Department Convention, with the exception of the Department Convention, which will be three or four days (3 or 4) days, total, and the other meetings shall be two or three days (2 or 3) days in length and shall be in the metropolitan Oklahoma City area. The Department Convention and Conferences may be extended one (1) additional day if required due to the amount of business required to be completed during the Convention or Conferences. The Commander -Elect may, at their option, hold their reception at a site place and date of their choice.

This Bylaws committee voted to recommend dis-approval as submitted of the above proposed bylaw change. This committee feels that this change allowing four (4) days of convention and other meetings extended a day in length would put an undue burden on not only the department coffers, but also on all in attendance. Furthermore, once prior arrangements with the hotel/hosting agency have been completed and contracts signed, this could cause legal and/or planning consequences on all parties involved. Having all Conventions/other meetings in the Oklahoma City area, while possibly may be nice, hotel/hosting agencies are at a minimum in the greater OKC area. This would constrain the Conference & Convention committee from looking outside the OKC area to possibly find the best low-cost deals throughout the state which would accommodate the needs and financial restrictions of the department and/or its Auxiliary. Furthermore, this Bylaws committee voted to amend the current bylaws as follows.

- **SB 12: Article VI, Section 1: Department Meetings, Section 1, last sentence**
 - **Currently reads**
 - The Commander-Elect may, at their option, hold their reception at a site, place and date of their choice.
 - **Proposed Change:** Strike out the entire sentence above.
 - **Would Read:** The department shall have a minimum of three (3) meetings a year. The Fall Festival, Mid-Winter Conference, and Department Convention, with the exception of the Department Convention which shall be three (3) days total, and the other meetings shall be two (2) days in length.
 - **Reason for change:** This bylaws committee feels that this is unnecessary wording in the bylaws since the Department Commander has the authority to hold a “Homecoming” at their leisure and at a place and time of his/her choice.
- **SB 13: Article VII – Council of Administration, Section 3**
 - **Currently reads**
 - When necessary to conduct Department business between Department meeting, votes may be taken by email or U.S. Mail. Council members shall be informed of the results within 2 weeks of the vote and the results of such votes shall be recorded in the minutes of the next scheduled Council of Administration meeting.
 - **Proposed Change:**
 - Amend Section 3 to read When necessary to conduct Department Business between Department meetings or convention, meetings can be conducted by a Zoom Conference call or any other electronic means. The Zoom meeting or any electronic meeting will be recorded and have its own minutes to include any and all votes taken during the Zoom or electronic meeting. All minutes will be published to the Council of Administration at the next scheduled meeting or convention.
 - **Would Read:** When necessary to conduct Department Business between Department meetings or convention, meetings can be conducted by a Zoom Conference call or any other electronic means. The Zoom meeting or any electronic meeting will be recorded and have its own

minutes to include any and all votes taken during the Zoom or electronic meeting. All minutes will be published to the Council of Administration at the next scheduled meeting or convention.

*This Bylaws committee voted to **recommend an amended version** of the above proposed bylaw change as shown below.*

- **Would Read:** When necessary to conduct Department Business between Department meetings or convention, stated meetings may be conducted or attended electronically that allow participating members to communicate with each other simultaneously. The electronic meeting will be recorded and have its own minutes to include any and all votes taken during the meeting. Minutes from said meeting will be published to the Council of Administration at the next scheduled meeting or convention.

SUPPORT FOR ADDING A 'RECOVERED AWAITING DNA CONFIRMATION' CATEGORY TO THE DEFENSE POW/MIA ACCOUNTING AGENCY (DPAA) AND IMPLEMENTING DNA MATCH NOTIFICATIONS THROUGH ANCESTRY WEBSITES

WHEREAS, the United States is committed to the fullest possible accounting for its missing service members from past conflicts; and

WHEREAS, the Defense POW/MIA Accounting Agency (DPAA) is responsible for recovering and identifying missing personnel but currently lacks a formal category for remains that have been recovered and are awaiting DNA confirmation; and

WHEREAS, the creation of a 'Recovered Awaiting DNA Confirmation' category within the DPAA would provide greater transparency to families of missing personnel and allow for better tracking of ongoing identification efforts; and

WHEREAS, many American families have submitted DNA samples to commercial ancestry and genealogy websites, which have databases that could assist in identifying remains of missing service members; and

WHEREAS, implementing a system that allows these ancestry services to provide notifications to individuals if their DNA appears to be a potential match for an unidentified service member, with proper consent and privacy safeguards, could significantly aid in expediting identifications and providing closure to families; now, therefore, be it

RESOLVED, by the Veterans of Foreign Wars Post 4938, that we urge the Veterans of Foreign Wars Department of Oklahoma to support and submit this resolution for consideration at the national level; and be it further

RESOLVED, that the Veterans of Foreign Wars of the United States petitions Congress, the Department of Defense, and the Defense POW/MIA Accounting Agency to establish a 'Recovered Awaiting DNA Confirmation' category and to explore partnerships with ancestry and genealogy databases to facilitate responsible DNA matching for the identification of missing service members; and be it further

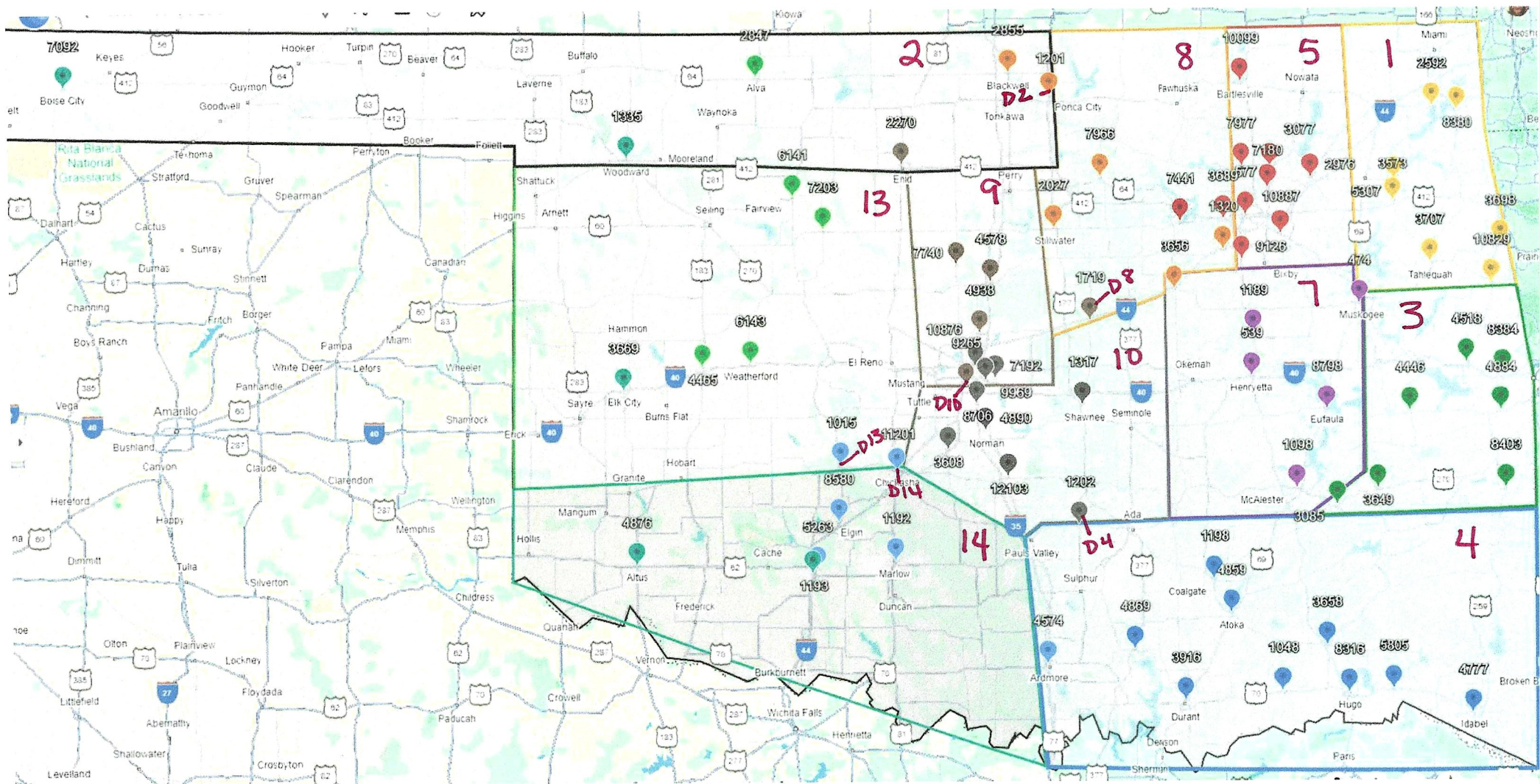

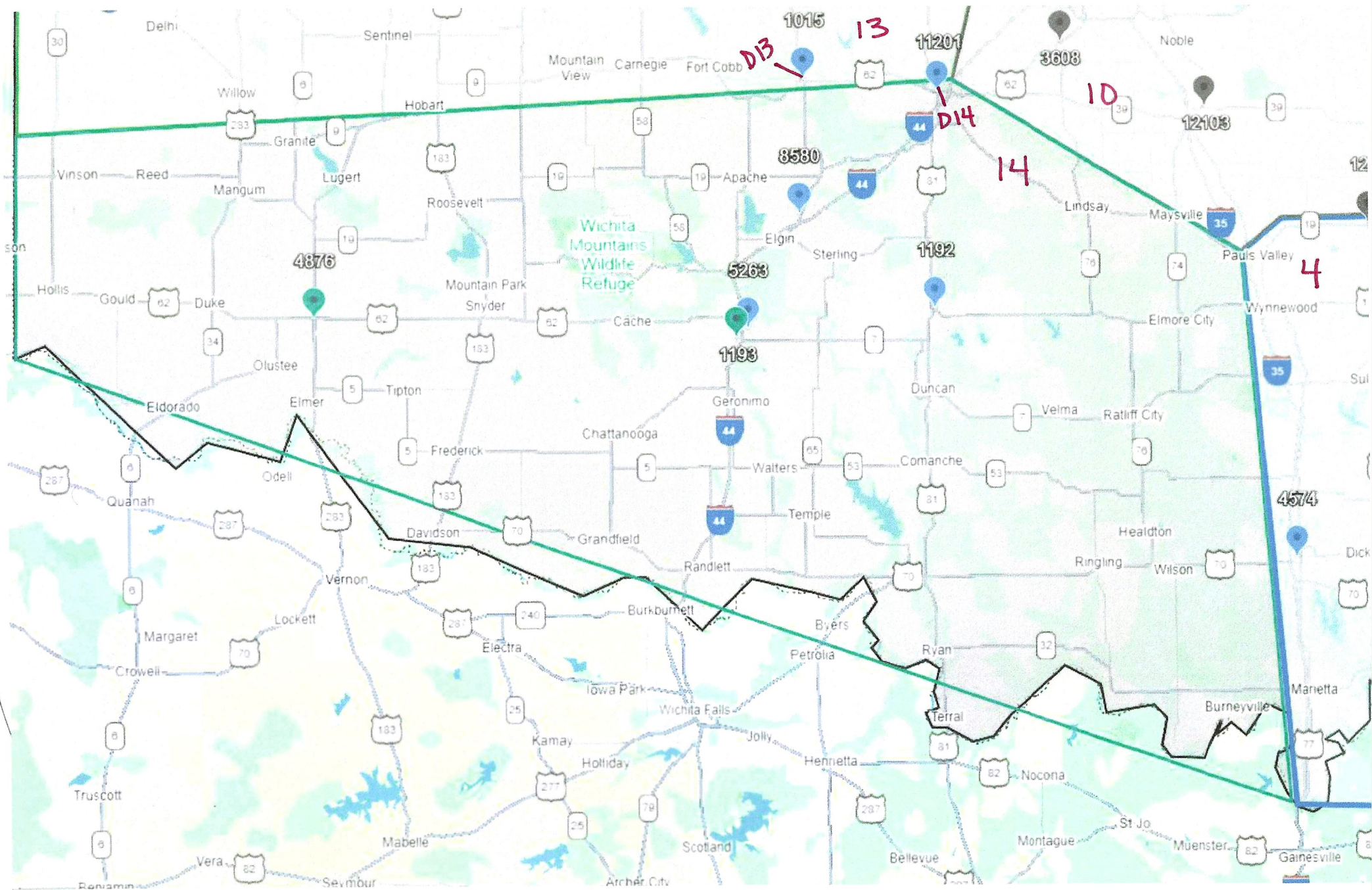

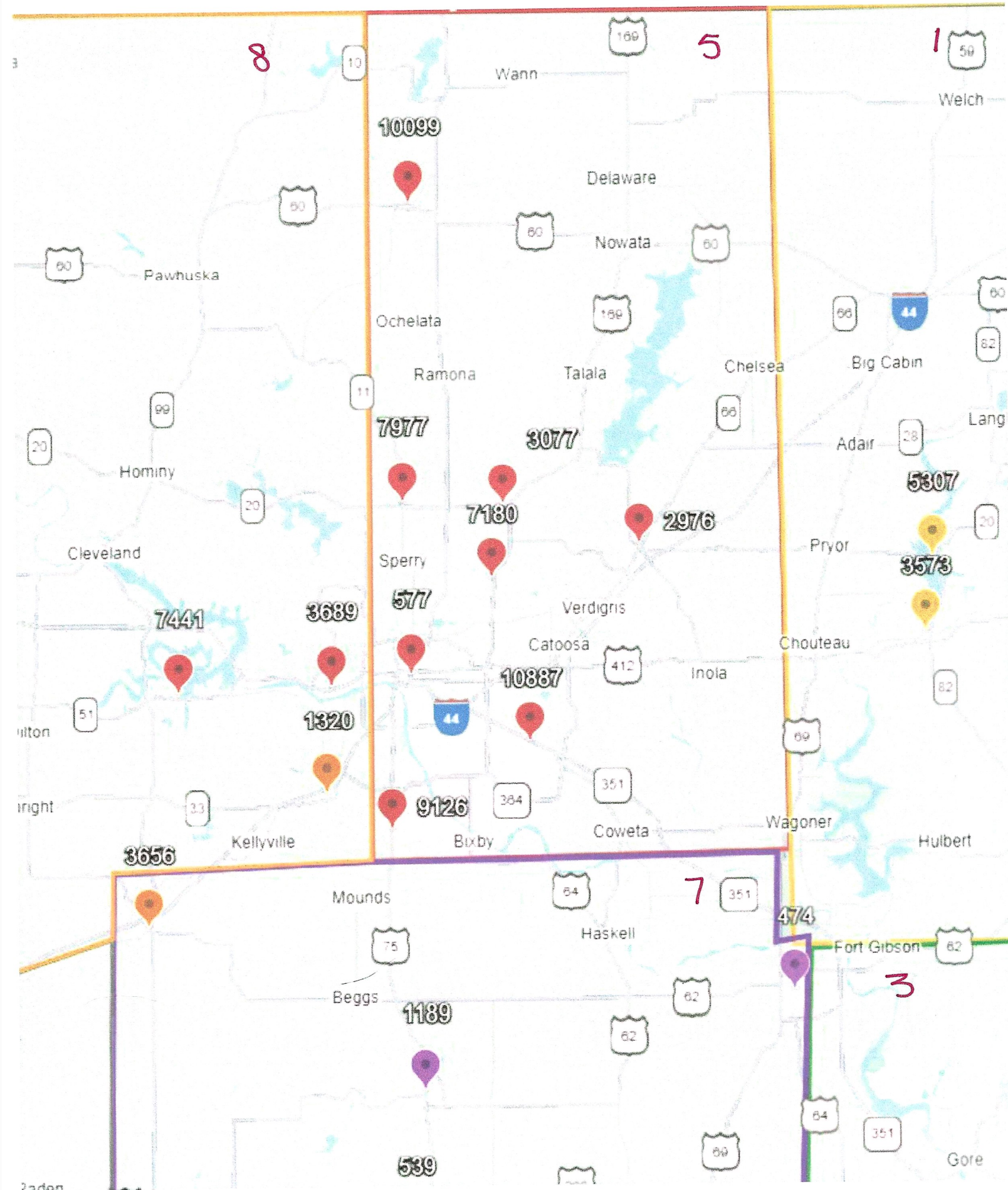
