2025-2026 Series

1. Commanders on all levels are reminded that according to Section 105 of the National Bylaws, a member whose dues are unpaid after their anniversary date ceases to be a member in good standing and loses all rights of membership in the Veterans of Foreign Wars. They shall not attend meetings or conventions and shall not participate in Post, County Council, District, Department, or National functions.

3. District Meetings Dates & Changes: District Commanders are reminded to notify the State Adjutant at okadj@vfw-oklahoma.org of any changes to district meetings including new dates for District meetings.

Judge Advocate *Randy Traxler*

“Life is like a box of chocolates, you never know what you are going to get.”

Forrest Gump said it, and leadership proves it true every single day. Much like that box of chocolates, leaders often come wrapped or shrouded in mystery until the moment they are called to serve. That is why you hear me talk so much about transparency and the trust it builds.

Leaders do not roll out of bed, stretch their VA rated disability ridden bodies, and declare that today is the day they lead. While that image is comical, it is almost what we see in action. Real leadership comes from growth. It comes from refining your skills and seeking mentorship like anyone else working to improve. Over the last few months, I have been doing exactly that. I have been reaching out across the National organization, attending Department meetings, sitting in on committees from other Departments, and watching how leaders think and react in different focused groups on social media. This includes the National Judge Advocate's parliamentary and bylaw learning group and Post discussion pages on Facebook.

What I have learned is that transparency does more than build trust. It increases efficiency. It boosts engagement. It helps Posts actually meet their chartered responsibilities. The Posts that have leaders working unilaterally or “in the shadows” are the ones struggling. They fight to recruit. They fail to retain. They end up dealing with issues that could have been avoided. I have read questions about basic responsibilities like the annual 990, trustee duties, and other administrative tasks. Almost all of these come from a lack of transparency and mentorship.

When we are transparent, we share information. We show how we conduct business. We are open to correction when we are wrong. And we adapt.

One of the best examples of what transparency looks like in real time came from a Department that allowed me to attend its monthly Commanders Call. This initiative tied to their All-State program is rooted in transparency, mentorship, and respect. It was not a formal meeting with motions and a strict structure. It was an informal Zoom call focused on leveling information across the Department. It was open to all elected and appointed officers, even though it mainly focused on the top five officers down to the Post level. It had a solid attendance record per the

Department leadership team. (To be honest it rivaled our attendance at Fall-Fest, for a smaller Department than ours).

Before the meeting the Adjutant sent out an All-State tracker. During the call the Commander went through updates in quick, neutral fashion.

“The Department is at X percent for membership.”

“District X you are two of six inspections complete.”

“Post XXXX you have two board members whose membership will lapse in 47 days.”

Facts. Not accusations. Not shaming. And because the data was delivered neutrally, no one tried to jump in and defend themselves. No one argued. It showed that the Commander was plugged in, tracking details, and ready to talk about them. After the Commander spoke, the Adjutant added updates and committee chairs with relevant information followed the same pattern.

The goal of all of this was transparency. What it provided was clarity. Everyone left the meeting with a clear picture of where things stood. Anyone with issues had instant access to the leadership team and to peers. Some stayed on afterward to fix problems immediately or to schedule follow up calls for mentorship.

To paraphrase that Commander, nothing we do is secret, so why not openly discuss it.

I was recently made aware that the National level the Council of Administration receives monthly updates that outline activity across Headquarters. These include Article IX actions that reach National, usually in the form of appeals, as well as notifications of closed Posts or Districts, consolidations, committee updates, and similar business. Even the things that most would clamor and stamp their feet shouting “this is protected and can’t be shared” were stripped of sensitive information just like the Department mentioned above did. They shared enough information so it could be tracked and the people who needed to know the specifics, e.g., the leaders who needed to renew membership, the leaders involved in the appeal chain etc. have different level of access but it is out in the open that leaders “see” those things.

So, I want to urge all of you to fulfill our chartered purpose through transparency and inclusion. Comrade Deric Duncan is doing it through his open committee call earlier in November. State Chaplain Marcus King is doing it through his open chaplain calls.

If we work together and communicate openly, we can reshape Oklahoma back into a powerhouse. To grow we just need a little light.

SportClips has completed their fundraising for the year. Still think about visiting and helping them out. As a reminder, this is a major talking point with potential members in uniform. This program has awarded \$195,900 to 47 military recipients in Oklahoma. Support this worthy program.
