**General Orders No. 03**

**2025-2026 Series**

1. Pursuant to National By-Laws Article VII Miscellaneous Provisions, Section 703, Bonds, "Each officer accountable for funds or property pursuant to any provision of these Bylaws shall be bonded with an indemnity company as surety in a sum at least equal to the amount of the liquid assets for which, so far as can be anticipated, they may be accountable. The bond premium shall be paid from the funds of the Veterans of Foreign Wars of the United States, Department, District, County Council or Post to which each officer is accountable. The bonds of such accountable officers, in amount and as to surety, shall be approved by their respective units and held by their respective Commanders. The Commander of each unit shall be responsible for the proper and adequate bonding of all accountable officers in their unit."
2. **Attention of Post & District Commanders & Quartermasters:** Commanders & Quartermasters are reminded at all levels of the annual requirement to complete an IRS 990, IRS 990N, for tax exemption requirements. Failure to complete the required IRS 990 may result in loss of tax-exemption status.
3. **Department Directory/Roster:** Commanders & Adjutants are asked to send all corrections, changes etc. of the Department Roster to [okadj@vfw-oklahoma.org](mailto:okadj@vfw-oklahoma.org) for changes.
4. **District Meetings Dates & Changes:** District Commanders are reminded to notify the State Adjutant at [okadj@vfw-oklahoma.org](mailto:okadj@vfw-oklahoma.org) of any changes to district meetings including new dates for District meetings.

Hi Comrades,

Well, it looks like fall has arrived. But what does that mean for us?

I guess the VFW could be compared to the fall season through the lens of transition, harvest, and preparation for a new cycle. Fall represents a critical period of winding down and reflecting, which is essential for organizational health and long-term sustainability.

Just as fall brings about a vibrant yet temporary change in nature, it represents a period of significant transition in an organization.

Shedding the old: Fall is characterized by trees shedding their leaves, letting go of what is no longer needed. In an organization, this corresponds to the “shedding”; of old ways of working, legacy systems, or outdated strategies that no longer serve the company.

It must have been difficult to start with because of their varied personalities and different directions and ideas they thought the order should go. Thankfully they must have realized at some point the only way to get started and form a viable association was to put it in writing and agree on what they wrote down. I have no way of knowing but, I can imagine the heated discussions, arguments and concessions made in the beginning. They formally adopted a constitution and bylaws in 1913.

Even today, 125 years later, we struggle with opinions, ideas, hopes and dreams for our beloved organization, thankfully they left us our Bylaws and Manual of Procedures to guide us in our deliberations and why we take an oath to abide by them to keep our just cause and mission pure and reachable.

This month, I leave you with this challenge; Be the Comrade you would like others to be and the Oklahoma VFW cannot fail in its mission.

Comrades,

Hello from the paw-paw patch. The National Convention is over, and the VFW made history. The first female Commander in Chief, a nomination from the floor for Senior Vice Commander in Chief and two roll call votes. Very interesting convention.

First, the nominee for Senior Vice Commander from the floor was elected as the new Senior Vice Commander with a vote of 4710 to 3448 on a roll call vote. The other roll call vote was for a bylaw change to section 615 eligible for appointment to a paid national position. No National Past Commander in Chief will be eligible until a minimum of 5 years has elapsed since their departure date.

Section 803 change was for alternative cap; baseball style was approved. The ball cap will be black in color, lettered with VFW initials, Post numbers, state, rank of office, Veterans of Foreign Wars and Cross of Malta may be worn by members other than officers during meetings of the Post and District. Lettering on each cap shall be in gold. The trim on the front bill shall be either gold, green, red, or silver corresponding to the official braid colors for the respective organizational echelon. The ball cap shall be an alternative to but not a replacement for the regulation overseas cap and shall not be worn in place of the regulation cap at formal ceremonies when in business attire or at events where the regulation cap is required. The ball cap will be available in November with a price of \$45 to \$50.

The National VFW Riders bylaws were approved.

Next year's convention will be in Reno Nevada. The Southern Conference and the Department of Oklahoma will need a good showing of delegates. Please think about going to the convention.

## *National Councillmember Curt Watts*

### **National Council Meeting & National Convention 2025 Back-Brief**

Comrades, I wanted to drop you a line to let you know that the VFW's Budget & Finance Committee (B&F Committee) meeting, the National Council Meeting and especially the National Convention 2025 was a success. A lot happened on the convention floor but let me first speak about the

B&F Committee and the National Council meetings first. Both of these meetings were held on the Saturday before the Convention.

Quartermaster General Marc Garduno and Chief Financial Officer Jim Lear briefed the B&F Committee and then the entire Council on the 3rd Quarter statistics for FY 24-25. Remember that while VFW State departments, districts and posts end their fiscal year on June 30, the VFW National fiscal year ends on 31 August.

As of June 30, VFW had \$1.5 Million in cash and \$121.8 million in our General Fund and Program investment portfolio. Our investments are split between our General Fund Reserve and several restricted programmatic funds. Although there has been plenty of volatility as we experienced an almost 20% decline in the S&P 500 during March and April, the VFW's total cash and investments have seen some overall growth since the end of our fiscal year ending August 31 2024. For the first ten months of the fiscal year, our cash investments have grown by almost \$4 million.

As always, the budget was broken down by each department within the National Headquarters (both Kansas City & Washington) allowing review of the revenue generated and especially the expenses accrued year to date. As of the 3rd quarter review, all departments were within the budget. Of course, there will be major expenses yet to be reviewed due to National Convention expenses which the B&F Committee and the Council will review when we meet in Kansas City in September. Once all FY 24-25 revenue & expenses are calculated we will know how we faired for FY 24-25. When the Council meets in Kansas City later in September is also when we approve the current Commander-in-Chief's budget.

## NOW FOR THE EXCITING STUFF! THE NATIONAL CONVENTION

Of course, as usual, the VFW recognized many sponsors, VA Secretary etc. and awards were handed out during these times. However, the real excitement started on Tuesday and continued into Wednesday when the resolutions, bylaws, manual of procedure, and rituals proposed changes were presented and passed or defeated by the convention of delegates. Nominations for National Officers started on Tuesday and finished with elections on Wednesday. If you have ever wondered about THE POWER OF THE MEMBERS and their voice, you would have seen this in progress during Tuesday and Wednesday's business sessions. First, the Tuesday business session was spent entirely (with the exception of officer nominations) on debate, more debate, and more debate and then voting for the proposed resolutions. On many occasions, the chair called for a rollcall vote of departments and national officers to obtain the final voting results. Let me point out that each post delegates within their department told the State Commander how to vote. In other words, one post may vote yes, while another post might vote no or a post may even split their vote. It was up to the Department Commander to state how many delegate votes for yeah & nay on the motion. This procedure truly exercised "the power of the members". On Wednesday, we finally were able to get into the proposed changes on the Bylaws, Manual of Procedure and Rituals. There were a few Bylaw changes that had extensive debate. Two was the one on a VFW baseball cap, and the other one was on the VFW Riders becoming a separate entity like the auxiliary and cooties. Both changes have passed.

Now for the election of National Officers. In the past over many years, the VFW has recognized the VFW Conference system where each of the four conferences would put the candidate of their choice from their conference in for the Commander-in-Chief, Senior Chief, Jr. Chief, Surgeon General, Judge Advocate General, and National Chaplain. Depending on the rotation, it determines which positions

would come from your conference. All went according to this Conference plan except for the Sr. Vice Commander-in-Chief position. According to the Conference plan Tim Peters who was the current Jr. Vice Chief from the Western Conference was to move up to the Sr. Chief position. However, the Big 10 Conference felt like Cory Geiser from Wisconsin would be a better choice. Collectively, the Southern Conference chose to back Cory as well. This is quite unusual, however fully allowed by our National Bylaws. Once both candidates were allowed to speak, a rollcall vote was conducted. Posts, Departments, National officers, and Past Commanders-in Chief voted. After the number of delegates were calculated, Cory Geiser from Wisconsin became our National Senior Vice Commander-in Chief for the FY 25-26 VFW year. Wow!

On a lighter note, I would like to say that the National Council approved the Committee on National Convention (Time & Place) proposals. In 2029, the VFW Convention will be held in Reno, Nevada and in 2030 we will be returning to New Orleans, Louisiana.

Fall is finally here! My second favorite season. Now is a great time to start getting the VOD and Patriot Pen information out to your schools. We have received a grant from Devon Energy that has allowed us to increase the Department scholarship for the winners, so let's get out there and get these kids involved.

This was my third National Convention to attend, and it was an interesting one. As Junior Vice Commander Larry Hurd mentioned there were two roll call votes. The members spoke and their voices were heard. It was proof that this a member driven organization.

If you have not already sent in the bond application, please do so as soon as possible. If you are bonded through an outside vendor or have a multi-year bond please send me a copy of the certificate or proof of bond. I have included the letter and questionnaire for the VFW Accountable Officer Bond and the VFW Club Manager/Employee Bond. The accountable officer bond is valid for September 1, 2025 – August 31, 2026, and the manager/employee bonds are valid for October 1, 2025-September 30, 2026. When you are filling out the questionnaire, please put the amount you want covered for not the total cost of the bond. The rates for both bonds are as follows:

- \$4.50 per thousand for \$3,000 - \$99,000 (example  $\$4.50 \times 3 = \$13.50$ )
- \$3.50 per thousand for \$100,000 - \$250,000 (example  $\$3.50 \times 100 = \$350$ )
- \$2.50 per thousand for \$251,000 - \$299,000 (example  $\$2.50 \times 251 = \$627.50$ )
- \$2.00 per thousand for \$300,000 - \$600,00 (example  $\$2.00 \times 300 = \$600$ )

As a reminder if you are mailing your 990 or audit to the Department make sure to keep a copy in your records. These are items that are checked during post inspections.

If you are calling the 1-800 number and having issues, call 405-364-8040 dial 0 and tell them you are using code **91H**. “Culture emerges from actions that are accepted.” – Dr. Alex Miller, Army Chief Technology Officer

When we reflect on the meaning of culture within our Posts and communities, it becomes clear that it is not defined by words alone, but by the actions we consistently choose to accept or reject. The VFW’s Congressional Charter, Bylaws, Manual of Procedure, and Ritual are more than administrative documents—they are the foundation of how we operate, serve veterans, and represent our organization to the public.

Culture does shift. A clear example was seen when, at last year’s Department Convention, officers nominated from the floor were publicly berated and shamed—an action inconsistent with the respect and dignity our organization demands. Yet just a year later, the Department demonstrated a

different posture, supporting those same actions when they occurred on the floor of the National Convention. This contrast underscores how culture can drift depending on what we collectively accept or allow.

Our charge is to ensure that our culture remains rooted in the bylaws and established procedures of the organization. The current culture, as reinforced through adherence to our governing documents, is one of accountability, order, and mutual respect. The previous actions, while tolerated at the time, were more likely aligned with personal beliefs or frustrations than with organizational values or authorized practices.

Our culture is the sum of these daily choices. By committing to the responsibilities entrusted to us and leading by example, we ensure our Posts reflect the honor, tradition, and camaraderie that define the Veterans of Foreign Wars. Let us strive to be deliberate in our actions, mindful that every accepted practice today will shape the culture of tomorrow.

Do you recognize this gentleman? His name is Joseph Virgil Fitts. He was born on the 18th of February 1890. He enlisted in the Army on the 6th of April 1917. He was promoted to 1st Sargent, Company C, 142nd Infantry. For those curious, he earned his VFW eligibility during World War I. He passed away on the 15th of March 1974. He was buried at Marsham Cemetery, Pawnee, Oklahoma. He was a member of Pollock-Stewart VFW Post 405, located in Pawnee, Oklahoma. He served as the Post Commander.

He was given a very hard task. Some may even say insurmountable. He created the Veterans of Foreign Wars, Department of Oklahoma. That is correct. He was appointed as the Department Commander on the 15th of January 1921 and charged with creating the organization that we are all members of. April 16th, 1921, the

Department of Oklahoma VFW held their first encampment with the purpose of voting in officers. As of that date, the fledgling Department had more than 900 members. Mrs. J. F. Capps, President of the Ladies' Auxiliary, as were other members were in attendance "to aid the furtherance of this branch".

I think he did a great job! Are we living up to his expectations? I certainly hope so. We have been living and supporting his work for 104 years.

Now that we know where we came from, let us look to the future for another 100 plus years of helping veterans.

For the Pawnee Post 7966, his goal was to erect a Memorial in the Highland Cemetery in Pawnee. Did he succeed it? Let us know.

**DEPARTMENT OF OKLAHOMA DISTRICT 14  
VETERANS OF FOREIGN WARS OF THE UNITED STATES**

**General Orders No. 01**

**2025-2026**

1. Pursuant to National By-Laws Article IV Districts, Section 418, Officers: Duties and Obligations, "Sec. 418 - Officers: Duties and Obligations.

(a) Officers.

(1) Commander. Among the duties of a District Commander, the Commander shall:

a. Preside at all meetings of the District conducting such convention and meetings in accordance with Article X and other applicable parliamentary rules and procedures.

b. Promote schools of instruction for Post officers at District meetings.

c. Enforce strict observance of the laws and usages of this organization, including District and Department Bylaws and the Congressional Charter, National Bylaws, Manual of Procedure and Ritual and all lawful orders from proper authorities.

d. Insist that District business and activities are conducted in such a manner that they do not violate any applicable governmental law, ordinance or regulation nor bring or tend to bring dishonor or embarrassment on the District, its members or the Veterans of Foreign Wars of the United States.

e. Decide all questions of law and usage in the District, subject to an appeal pursuant to these Bylaws.

f. Appoint officers, committee chairmen and committees not otherwise provided for. The Commander may remove such appointed officers, committee chairmen and committees at their pleasure.

g. Approve all disbursements of funds properly authorized by the District by use of a voucher or payment order.

h. Assure that the office of District Quartermaster is bonded according to Section 703 of these Bylaws.

i. Assure that all monies due the Department and National Headquarters are forwarded promptly.

j. Assure that all reports are correctly prepared and promptly forwarded and that all the business of the District is handled with dispatch.

k. Assure that the District Trustees have examined the books and records of the District and prepared the District Trustees Report of Audit. The Commander shall forward a copy within thirty (30) days to the Department Quartermaster for referral to the Department Inspector.

l. Assure that the District Inspector has properly inspected the books and records of the Posts within the District in accordance with the Department Bylaws or as directed by the State Commander.

m. Assure that eligible veterans are encouraged to join and maintain membership.

n. Be an ex-officio member of all committees.

o. Serve as a member of the Department Council of Administration."

2. Pursuant to National By-Laws Article IV Districts, Section 218, Officers: Duties and Obligations, "Sec. 218 - Officers and Chairmen, Duties and Obligations.

(a) Officers.

(1) Commander. Among the duties of a Post Commander, the Commander shall:

a. Preside at all meetings of the Post, conducting such meetings in accordance with Article X of the Bylaws and Manual of Procedure and other applicable parliamentary rules.

b. Enforce strict observance of the laws and usages of this organization, including Post, County Council (if applicable), District and Department Bylaws and the Congressional Charter, National Bylaws, Manual of Procedure and Ritual and all lawful orders from proper authorities.

c. Insist that Post business and activities be conducted in such a manner that they do not violate any applicable governmental law, ordinance or regulation nor bring or tend to bring dishonor or embarrassment upon the Post, its members or the Veterans of Foreign Wars of the United States.

d. Decide all questions of law and usage in the Post, subject to appeal pursuant to the Bylaws.

e. Upon entering into office, appoint all other officers, committee chairmen and committees not otherwise provided for. The Commander may remove such appointed officers, committee chairmen and committees at their pleasure.

f. Approve all disbursements of funds properly authorized by the Post by use of voucher or payment order.

g. Assure that the office of Quartermaster is bonded according to Section 703 of the Bylaws.

h. Assure that all dues and other monies due the National Headquarters and Department are forwarded promptly together with accurate reports and returns pertaining thereto.

i. Assure that all reports are correctly prepared and promptly forwarded, that all the business of the Post is handled with dispatch and that all necessary licenses and permits are obtained for proper operation. Ensure that a properly completed Report of Election of Officers for the ensuing year is submitted to Department and National Headquarters by June 1.

j. Assure that the Post Trustees have examined the books and records of the Post and prepared the Post Trustees Quarterly Report of Audit no later than the end of the month following the last day of each quarterly period.

k. Assure that the Commander or their representative attend all properly called District Conventions or meetings and County Council meetings (if applicable).

l. Comply with and perform all of the duties required by the laws and usages of this organization, the provisions of these Bylaws, the Manual of Procedure and Ritual and Department, District, County Council (if applicable) or Post Bylaws pertaining to the duties and obligations of a Post Commander and lawful orders from proper authority and perform such other duties as are usually incident to the office.

m. Be an ex-officio member of all committees.

2. Attention of Post Commanders: All post inspections will be completed before December 20, 2025, so they can be submitted to the department by the due date of December 20, 2025. Post commanders are recommended to review MOP section 218(a)(1)k which directs the commander or their representative to attend all properly called district conventions or meetings. Failure to do so may not accurately represent the best interests of that post membership and demonstrate a failure to fulfill the duties of office specified in 218 of the bylaws and MOP.

3. District Communication: In order to develop a timely and cost effective pace plan for communications within the district we will use email as our primary, telephone calls as our alternate, traditional post mail as our contingency and face-to-face communication as our emergency communication. Please make sure that your information is correct and up-to-date on the election reports.

4. District Meeting Dates & Changes: District meetings are published in advance to allow everyone the opportunity to be present. If a Post Commander cannot be present, they shall send an authorized representative, i.e. SVC or JVC in their place for the meetings. The upcoming district meetings will be held on OCT 4, 2025, FEB 7, 2026 with an alternate date of FEB 28, 2026 (inclement weather), and APR 25, 2026. All meetings will be held at 1000 hours. Place TBD by the posts in the district. If your post can host a meeting please let the district adjutant, Ron Albert, know so we can get them updated with the department. There will be a SOI held at the next regularly scheduled district meeting.

Thank you for everything you do for your veterans, their families, and your communities. I look forward to serving the department in my new roles. Please reach out if you need anything, now and in the future.
