Hello from the paw-paw patch in southwest Oklahoma. First, I would like to thank the membership from all of the posts and districts that voted for me to represent you as the state surgeon. It is an honor for me to fill the surgeon position. I am currently on the Oklahoma Veterans Affairs Council and at this meeting I receive a lot of valuable information from the VA, ODVA and our state and federal legislators. For me to get this information out to our membership I use the department slack program. Slack can be found on Google Play or App store. After downloading the app look for Department of Oklahoma. I will also use the general orders to get the information out to the membership.

Here is some information from our last VAC meeting, The OKC VAMC Director: Director Vlosich: Spoke on testifying in front of congress about healthcare for rural veterans. Part of the Northside clinic is opened. The pain clinic is moving back to North May Clinic. The new location for the women's clinic will be across the street from Baptist Integris Hospital in the Homeland Security Building. The Norman clinic is at capacity and they are looking at a new location. The new Yukon Clinic is opening soon. Vanita and Claremore are opened. They are moving to the second floor at Tinker AFB Clinic. There have been 7,530 new users enrolled this year. The south clinic will be opening a dental clinic in August. The ORICU is under construction along with other projects.

A report from Jack C. Montgomery VAMC: Director Denning: Shane Glover spoke on the Tulsa Hospital construction is still on target for a 2026 opening. The Cherokee Nation is partnering with the Vinita Clinic. Provided an update on the recent PACT Act events.

**FEDERAL ISSUES: Veterans Omnibus Introduced.** After months of waiting, a comprehensive legislative package of veterans-related bills has finally been introduced. H. R. 8371, the Senator Elizabeth Dole 21st Century Veterans Healthcare and Benefits Improvement Act, combines several bipartisan and bicameral proposals to reform and improve the delivery of healthcare, benefits, and services at the VA for veterans, their families, and survivors into a single package. Provisions in H.R. 8371 would expand economic opportunities for veterans, improve mental health care access and facilitate better oversight of the VA by Congress. Most important, the bill includes the entire Elizabeth Dole Home Care Act which: Increases the expenditure cap for non-institutional care alternative programs from 65 percent to 100 percent of nursing home care costs; Expands access to VA's home and community-based services to veterans at all VA medical facilities, as well as to veterans living in U. S. Territories and Native veterans enrolled in the Indian Health Service or tribal health programs; Requires the creation of centralized website to disseminate information and resources related to home and community-based programs and help veterans and caregivers determine their eligibility; Requires the VA to review staffing and resource needs, accessibility, and other aspects of the Office of Geriatrics and Extended Care and the Caregiver Support Program Office to make certain they are appropriately serving veterans and their caregivers; Create a pilot program to provide home health aide services for veterans and caregivers who are discharged from or ineligible for the Program of Comprehensive Assistance for Family Caregivers.

The bill also contains revised language from the Expanding Veterans' Options for Long Term Care Act (H.R. 1815/S. 495), which would test VA's ability to pay for veteran's care at assisted living facilities. Currently, the VA can refer veterans to assisted living facilities, but it cannot directly pay for that care. Language in H.R. 8371 would allow VA to carry out a three-year pilot program, no later than two years after enactment for 60 eligible veterans in two Veterans Integrated Service Networks (VISNs) to assess the effectiveness of providing assisted living services to eligible veterans and assess the satisfaction of the program. At the conclusion

of the pilot program, participating veterans will be given the option to continue receiving assisted living services at their assigned site, paid for by the VA. We believe this would help veterans and the VA alike by giving greater access to assisted living and reducing costs for long-term care, allowing more veterans to receive assistance.

The weather is starting to heat up all over the state. Take precautions by drinking plenty of fluids, stay in the air conditioning and out of the sun and check up on your relatives, neighbors and the VFW comrades. Wear light weight loose fitting clothing and a hat or ball cap and take frequent breaks. Stay cool, stay hydrated, stay informed and enjoy the Fourth of July and your summer activities.

First off, I want to thank everyone who supported me in my run for State Quartermaster. As I said in my campaign speech, the members of this organization have given me a lot of support and I want to give back. Moving on to business, as Adjutant my goal is to have the General Orders out by end of day on the last day of the month prior to the month that the General orders apply to, and at the very latest by COB on the first day of the month that the General Orders apply to. If anyone has anything they would like published in the General Orders, I ask that it be submitted to [vfwokadj@outlook.com](mailto:vfwokadj@outlook.com) by the 25<sup>th</sup> of the month.

Once the commander has his appointments made, I will be putting together a Department Directory. I will send it out via Constant Contact, and I will work with our Public Relations officer to have it available on the website; [vfwoklahoma.org](http://vfwoklahoma.org).

In accordance with Section 703 of the National Bylaws “Each officer accountable for funds or property pursuant to any provision of these Bylaws shall be bonded with an indemnity company as surety in a sum at least equal to the amount of the liquid assets for which, so far as can be anticipated, they may be accountable. The bond premium shall be paid from the funds of the Veterans of Foreign Wars of the United States, Department, District, County Council or Post, as the case may be, to which each officer is accountable.

The bonds of such accountable officers, in amount and as to surety, shall be approved by their respective units and held by their respective Commanders. The Commander of each unit shall be responsible for the proper and adequate bonding of all accountable officers in their unit.

The last page of these General Orders is the questionnaire for the VFW Accountable Officer Bond. The accountable officer bond is for September 1, 2024 – August 31, 2025. Again, this is for the VFW Accountable Officers only, the questionnaire for the Clubroom, Canteen, and Bingo Employees will come at a later date, those bonds are for October 1, 2024-September 30, 2025. I will send this questionnaire out again with the August General Orders. The rates for the bonds are as follows:

- \$4.50 per thousand for \$3,000 - \$99,000
- \$3.50 per thousand for \$100,000 - \$250,000
- \$2.50 per thousand for \$251,000 - \$299,000
- \$2.00 per thousand for \$300,000 - \$600,00

Your April 1- June 30 quarterly audit is due by July 31. Also, if you are fiscal (July 1 – June 30) tax filer your annual 990 can be done anytime from July 1 – November 15. The IRS deadline is November 15. My recommendation is don't wait, especially if you are a 990N (e-postcard) filer. If you use a CPA, get your files to them as soon as possible. Once you have it filed email or snail mail a copy to [vfwhqokqm@outlook.com](mailto:vfwhqokqm@outlook.com) or PO Box 1126, Oklahoma City, OK 73101.

We have our first School of Instruction coming up on July 20 at post 577 in Tulsa, as reminder Schools of Instruction are open to all members. We also have officer training coming on August 17<sup>th</sup> and 18<sup>th</sup> at the Embassy Suites on South Meridian in Oklahoma City. You probably noticed it is earlier in the year this year. Commander Fuller felt if we held it earlier in the year, we would have a better chance of setting each officer up for success. We want you all to have a successful year and want to do what we can to help you succeed.

Dear Comrade Commander:

Questionnaire for VFW Accountable Officers Crime Coverage

August 1, 2024

One of the most important communications you will receive during the year concerns the bond of your Unit Quartermaster. Section 703 of our National By-Laws requires that each accountable officer shall be bonded with an Indemnity Company as surety and the By-Laws places the responsibility for adequate bonding upon the Commander of the post. In any business it is customary to bond any officer handling funds. **THE BOOKS AND RECORDS OF THE ACCOUNTABLE OFFICER MUST BE AUDITED AT LEAST QUARTERLY BY THE TRUSTEES. THIS IS TO COMPLY WITH SECTION 218 OF THE NATIONAL MANUAL OF PROCEDURES.**

The Department Headquarters carries a Crime Policy for the bonding of Department and Post Accountable Officers. This Policy runs for a year – from September 1 to August 31 – premium payments are made on that basis. Coverage for all accountable officers expires on August 31 and premium for the New Year is due on September 1.

Any unit may decide whether it prefers to take out a Policy with some other surety company or have its funds protected by the Department Headquarters Crime Policy. But the matter should be given prompt attention because if your Accountable Officer had previously been covered through the National Headquarters, **a new premium payment is required by September 1, 2024 and delinquent after this date.**

**IF THE POLICY IS NOT RENEWED, TERMINATED, OR CANCELLED AT EXPIRATION DATE OF 9-1-2023, THE POST HAS ONLY 90 DAYS TO SUBMIT A PROOF OF LOSS FOR PRIOR TERM. AFTER 90 DAYS PRIOR COVERAGE CEASES.**

**COVERAGES OF THE POLICY REQUIRE THAT:**

1. You agree to make/or cause to be made, at least annually, an audit of your books and accounts, including complete verification of all securities and bank balances pertaining to each “employee and/ or volunteer”.

If the above is not complied with, the Insurance Company will refuse to honor claim of missing funds which cannot be proven by records. Monthly audits and reconciliation of bank statements may avoid this denial of claim.

2. The Insurance Company will not pay for loss resulting from any unauthorized advances made by an “employee” to any member for delinquent dues and assessments.

3. “Employee” means any duly elected position, or any appointed officer as listed in the policy schedule.

**4. POST MUST SUBMIT A PROOF OF LOSS FORM WITHIN 120 DAYS FROM THE FIRST DATE OF DISCOVERY OF THE LOSS. Proof of loss resulting from dishonest acts on the part of the bonded officer is required in settlement of claims.**

**THIS POLICY IS ONLY FOR THE YEAR SEPTEMBER 1, 2024 TO AUGUST 31, 2025.**
